Abstract

We show how to compute financial exposure networks that carry a minimum of systemic risk, and — at the same time — have the same economic efficiency and value as the actually observed networks. We show the approach for financial risks coming from overlapping portfolios and for direct exposures. Optimal networks can be used as benchmarks for monitoring actual systemic risk in financial markets.
